THE LATE CITY EDITION OF "THE KOREA HEARLD," A SEOUL, KS, ENGLISH LANGUAGE DAILY NEWSPAPER FOR 18 OCT 79, CARRIED THE FOLLOWING HEADLINES AND SUPPORTING ARTICLE:

QUOTE - IN WAKE OF STUDENT RALLIES - MARTIAL LAW PROCLAIMED ON PUSAN (PUSAN, KS). LT. GEN ((PAK)) HELMS COMMAND: CURFEW EXTENDED ONE HOUR (END HEADLINES). THE GOVERNMENT PROCLAIMED THE MARTIAL LAW IN PUSAN AS ON. 0:00 A.M. TODAY AND APPOINTED ARMY LT. GEN. ((PAK)) CHAN-GUNG AS COMMANDER OF THE MARTIAL LAW COMMAND.

THE DECISION TO PROCLAIM THE MARTIAL LAW WAS MADE AT AN EMERGENCY CABINET MEETING CALLED AT THE CAPITOL BUILDING

AT 11:30 P.M. YESTERDAY. THE MEETING, CHAIRED BY PRIME MINISTER ((CHOI)) KYU-HAH IN THE PRESENCE OF THE ENTIRE CABINET, DECIDED ON THE MEASURE ONLY THREE MINUTES AFTER IT WAS CONVENED.

IN MAKING THE ANNOUNCEMENT, MINISTER OF CULTURE AND INFORMATION ((KIM)) SEONG-JIN, CONCURRENTLY SPOKESMAN FOR THE GOVERNMENT, SAID THE PROCLAMATION OF THE MARTIAL LAW, BASED ON ARTICLE 54 OF THE CONSTITUTION, WAS TO MAINTAIN PUBLIC ORDER IN THE PORT CITY.

KIM SAID THE GOVERNMENT WILL MAKE EVERY EFFORT TO ENSURE THE NORMAL ACTIVITIES OF PUSAN CITIZENS WHO RESPECT LAW AND ORDER WHILE THE CITY IS UNDER MARTIAL LAW.

THE GOVERNMENT WILL ALSO SEE TO IT THAT NO INCON-VENIENCE IS CAUSED TO THE FOREIGNERS STAYING IN THE CITY.

KIM ADDED. WITH THE PROCLAMATION OF THE MARTIAL LAW, HE SAID, THE CURFEW HOURS IN THE CITY WILL BE EXTENDED BY ONE HOUR FROM 11:00 P.M. TO 4:00 A.M.

THE GOVERNMENT SPOKESMAN CALLED FOR COOPERATION ON THE PART OF THE PUSAN CITIZENS. SO THAT THE EMERGENCY MEASURE COULD BE LIFTED AT AN EARLY DATE.
