TRIALS IS SPARSE; THE INDICTMENT HAS NOT BEEN PUBLICIZED; AND THE PRESS HAS MENTIONED THE TRIALS ONLY BRIEFLY, WITH NO DAY-TO-DAY COVERAGE. NAME OF THESE HAVE ASKED, WITH FAMILY CONSENT, TO FILL SOME OF THESE SEATS, BUT THESE REQUESTS HAVE BEEN TURNED DOWN. IN AN UNUSUAL CONCESSION, THE AUTHORITIES HAVE PERMITTED PRAY-INS AND FAMILY VIGILS OUTSIDE THE CAMP GATE, AS LONG AS THESE GATHERINGS ARE ORDERLY. 7. COMMENT: THE NUMBER OF PEOPLE BEING TRIED IS SMALL COMPARED TO THE HUNDREDS OF THOUSANDS WHO PARTICIPATED IN ONE WAY OR ANOTHER IN THE KWANGJU UPRISING. YET TIGHT SECURITY AROUND THE COURTROOM INDICATES THAT THE GOVERNMENT HAS NO ILLUSIONS ABOUT THE INTENSITY OF LOCAL FEELING, FEELING WHICH COULD LEAD TO THE CREATION OF MARTYRS SHOULD THE EVENTUAL SENTENCES BE TOO HARSH. 8. WE HAVE JUST SEEN AN AFP REPORT THAT TWO PRIESTS WHO ARE AMONG THE DEFENDANTS RECEIVED JAIL TERMS OF 7 AND 15 YEARS, RESPECTIVELY. THE STORY QUOTES THE PROVINCIAL GOVERNOR THAT "THE TRIAL WILL BE CONDUCTED JUSTLY AND THE AUTHORIPIES WILL BE LENIENT," ALTHOUGH HE REFUSED TO CONFIRM OR DENY THAT SOME DEATH SENTENCES WOULD BE HANDED DOWN.
