8A. (U) DETAILS:

- FOLLOWING AN EMERGENCY CARINET SESSION

 DURING THE EVENING OF 17 MAY, THE ROK GOVERNMENT HOVED TO STRENGTHEN MARTIAL LAW BY DECLARING "EYTRAGROINARY" MARTIAL LAW, EFF 2400 HOURS (17MAY). THE TEXT OF THE MARTIAL LAW DECRFE WAS FORMARDED VIA SEPARATE IR (SEE IR THIS WAS APPARENTLY A FOLLOW-ON TO PRIME MINISTER (SHINT) HYON-HWACK'S STATEMENT THURSDAY NIGHT THAT THE GOVERNMENT MOULD NOT REMAIN IDLE IF THE STUDENTS CONTINUED TO DISPUPT THE PUBLIC ORDER.
- APPROXIMATELY 18 STUDENT LEADERS HAVE BEEN ARRESTED. ALONG WITH ((KIM)) JONG PIL AND ((KIM)) TAE CHUNG. COLLEGE CAMPUSES ARE CLOSED.
- ONWITHIN SECUL AS OF 0830. 18 MAY (SUNDAY)
 WAS GUTET. SEVERAL APCS, FIAT ARMORFD CARS (5614) AND
 TROOPS IN FULL-FIELD GEAR WERE PRESENT AT MOST GOVERNMENT
 BUILDINGS, TO INCLUDE THE CAPITAL, SECUL CITY HALL, AND
 GUVERNMENT OFFICE RUTLDINGS. TROOPS AND APCS WERE ALSO
 NOTED AT BANKS AND NEWSPAPER BUILDINGS. THE UNIVERSITY
 ENTRINCES ARE BLOCKED AND OCCUPIED BY TROOPS. THE SITUATION REGARDING TROOP DEPLOYMENTS APPEARS SIMILAR TO THE
 OCTORED 1972 MARTIAL LAW WHEN THE UNIVERSITIES WERE CLOSED.
 A SHOT CHECK OF NEARRY UNIVERSITIES TODICATES THAT CAPITAL
 SECURITY COMMAND FORCES ARE INVOLVED. IT IS ALSO PRORABLE
 THAT SPECIAL MARFARE COMMAND FORCES ARE INVOLVED. ALTHOUGH
 THIS HAS NOT BEEN CONFIRMED BY VISUAL OBSERVATION AT THIS
 - THERE IS AN ARMORMALLY LARGE. YOUTHFUL AND RAGRAGE-LESS CROWN AT THAT LOCATION.
