LOCAL TIME ROKA WAS ORDERING OFFICERS FROM THE CHOLLA
PROVINCES TO KWANGJU FOR RIOT CONTROL DUTY. THE RATIONALE
IS THAT THESE OFFICERS WILL HAVE MORE SUCCESS IN QUELLING
DEMONSTRATORS THAT OTHERS DUE TO THEIR PROVINCIAL TIES,
KNOWLEDGE AND ACCENTS. [REDACTED] STATED THAT THESE ORDERS
WERE MEETING WITH SOME LIMITED RESISTANCE BUT WERE FOR THE
MOST PART BEING GRUDGINGLY OBEYED.
