3. AS FOR THE WAY WE HANDLE CHUN DOO HWAN AND OTHERS, I SUGGEST YOU HOLD BACK YOUR COMMENTS ON MY ASSESSMENT AND OTHER REPORTS UNTIL YOU HAVE RECEIVED A POLICY RECOMMENDATION CABLE FROM ME. I HAVE WRITTEN IT, BUT WANT TO SHOW IT TO JOHN WICKHAM AND BOB BREWSTER AND A FEW OTHERS BEFORE I SEND IT TO YOU EARLY NEXT WEEK, GLEYSTEN
