1. (U) RADIO BROADCAST AT 11 A.M. MAY 22 STATEMENT BY
MARTIAL LAW COMMAND OF INTERIM FINDINGS IN INVESTIGATION
OF KIM DAE JUNG (M-R: KIM TAE-CHUNG). ACCORDING TO
STATEMENT, KIM HELD MEETINGS WITH STUDENTS, FINANCED
THEM, AND GUIDED THEM TOWARD AN "UPRISING." DEALINGS
OF KIM OR HIS ASSOCIATES WITH VARIOUS STUDENT LEADERS
MENTIONED. SEVERAL REFERENCES WERE ALSO MADE TO KIM'S
ALLEGED LEFTIST BACKGROUND.

2. (C) COMMENT: STATEMENT APPARENTLY PREPARING THE
WAY FOR LEVELLING OF FORMAL CHARGES AGAINST KIM. WE
TRIED UNSUCCESSFULLY TO DISCOURAGE ISSUANCE ON GROUNDS
THAT IT WOULD INFLAME, NOT CONCILIATE, THE PEOPLE OF
THE CHOLLA PROVINCES, THUS ADDING TO DANGEROUS TROUBLE
IN KWANGJU.
