WE COUPLE OUR PUBLIC WARNING TO THE NORTH KOREANS WITH URGENT DIPLOMATIC REPRESENTATIONS TO THE CHINESE AND SOVIETS. I DID NOT RECOMMEND THIS INITIALLY BECAUSE I THOUGHT IT WAS UNNECESSARY. AS A RESULT OF THE KHANGJU PROBLEM, I THINK IT IS ESSENTIAL, AND I HOPE THE PROBLEM APPROVE DOING SO ON AN EMERGENCY BASIS. IN ADDITION, I AM STRONGLY RECOMMENDING A FURTHER USG STATEMENT ON KWANGJU TO BE ISSUED TODAY YOUR TIME (SEPTEL).
